Category I: Engineering Graduate Apprentice-A degree in Engineering or Technology, granted by a Statutory University or A Degree in Engineering or Technology, granted by an Institution empowered to grant such Degree by an Act of Parliament or Graduate Examination of Professional bodies recognized by the Central Government as equivalent to Degree

Category II: Technician (Diploma Holder) Apprentice-A Diploma in Engineering or Technology, granted by a State Council or Board of Technical Education established by a State Government or A Diploma in Engineering or Technology granted by an University or A Diploma in Engineering or Technology granted by an Institute recognized by the State Government or Central Government as equivalent to above.

Category III: MBA Trainees- A Degree in Master of Business Administration from a recognized University or Institution empowered to grant such Degree by an Act of Parliament.

Age -Upper age limit is 26 years as on 15-04-2015. The upper age limit is relaxable by 5 years for SC/ST candidates, 3 years for OBC candidate and 10 years for persons with disability.

Reservation: The Provisions of Government directives for engagement of Apprentices in the SC, ST, OBC & PWD Category will be applicable.

Selection: Selection will be done through personal interviews

TA/DA: No TA/DA will be given at the time of selection test/interview as well as at the time of joining in training.

Employment: No promise of employment after expiry of training period

Eligibility:

- Only Indian Nationals are eligible to apply
- Candidates who have secured 60% and above marks in their final examination.

Other Terms & Conditions: for Category I & II

- Engineering Graduate or Diploma holder who had training or job experience for a period of one
 year or more, after the attainment of the required qualifications shall not be eligible for being engaged
 as an apprentice under the Apprentices Act 1961
- The training will be governed by the Apprentices Act, 1961 as amended in 1973 & 1986'
