- (b) A Diploma in any branch of Engineering or Technology recognized by the State Board of Technical Education or equivalent with additional one year Diploma Course in Industrial Safety Engineering (60% marks) and one year Diploma course in Fire Safety Engineering (60% marks) from the Directorate of Technical Education/ Central Labour Institute/ Regional Labour Institute / Supervisory Development Centre, Govt. Of Kerala, with **5 (five) years** experience in a reputed integrated Pulp & Paper Mill or in large Chemical/Semi-chemical Process Industry.
