GLOBAL NOTICE INVITING BIDS

Hindustan Newsprint Limited invites bids from reputable manufacturers/their associates for the following:

1.0 Pre-qualification criteria

- 1.1 The Bidder shall be an internationally reputed manufacturer of De-inking Plant process line equipment with key equipment such as continuous drum pulper, flotation cell and disperger in their manufacturing range.
- 1.2 The Bidder shall have supplied and commissioned at least three De-inking Plants during the preceding seven years, with at least one plant for the production of De-inked pulp for LWC/writing and printing paper grades. Out of the three plants, at least one plant shall be for the production of minimum 300 TPD De-inked pulp and the others for the production of minimum 200 TPD De-inked Pulp.
- 1.3 The scope of supply for the three references mentioned in Clause No.1.2 above shall include critical process line equipment – continuous drum pulper, centricleaner, flotation cell, screens, washer, screw press, disperger and disk filter. Any of these equipment not covered in the scope of supply for these references, if supplied for different projects of minimum capacity of 200 TPD De-inking Plant will be acceptable. Such equipment shall have at least three references in the past seven years and successfully commissioned.
- 1.4 The Bidder shall have recorded an average annual turnover of US\$ 300 million in the three preceding accounting years.
- 1.5 The Bidder shall have registered Profit Before Tax (PBT) in at least two years during the three preceding accounting years.

2.0 Associate

- 2.1 The Bidder may engage another firm for the selective co-ordination of the project activities and/or supply of certain non-critical deliverables under the project scope. The firm thus engaged, if any, shall either be a group company/subsidiary of the bidding firm or a business partner of it.
- 2.2 In the event of the Bidder engaging any firm other than a group company/subsidiary for any project activity specified under the scope of the Bid, then the firm thus engaged shall have proven references for executing the said activities in a successful manner. HNL reserves the right to verify the credentials of the firm and accept/reject the proposal to enlist the support of the said firm for this project.
- 2.3 The firm thus engaged, should have registered Profit before Tax (PBT) in at least two years during the three preceding accounting years.

EMD/Bid Security shall be furnished by means of a Demand Draft drawn in favour of HINDUSTAN NEWSPRINT LIMITED, payable at Ernakulam/Cochin from any Indian Scheduled Commercial Bank or from a reputed Foreign Bank along with the techno-commercial bid. Alternatively, the same can be furnished by means of a Bank Guarantee, as per our Proforma, valid for 180 days, from an Indian Scheduled Commercial Bank or from a reputed Foreign Bank or Correspondent Indian Bank of the Foreign Bank.

The bids prepared in the manner mentioned in the bid document will be received till 14.00 hrs. (IST) on 26.07.2010 along with the Bid Security specified, which will be opened on the same day at 14.30 hrs. (IST) in the presence of interested Bidders.
