Pre-qualification criteria

1. The Bidder shall be a renowned consultant engaged in providing project management consultancy services in the field of Pulp & Paper. The skill profile of the consultant shall necessarily include integrated project management consultancy services by providing engineering, procurement services, project and civil construction management. The Bidder should have successfully completed atleast one assignment as Project Management Consultant during the immediately preceding 10 years for the successful completion and commissioning of a De-inking plant of capacity 100 TPD or higher.

OR

If the Bidder is not experienced in the Pulp and Paper domain but having experience in providing project management consultancy with skill profile of providing engineering, procurement services, project and civil construction management services in any continuous process industry is eligible to quote, provided they have an alliance partner who fulfills the criteria in respect of experience in Pulp and Paper. In that case, the bidder should have successfully rendered project management consultancy for atleast 3 completed projects, the value of each project not less than Rs.50 crore in the preceding 5 years. Further, the alliance partner should have successfully completed atleast one assignment as Project Management Consultant during the immediately preceding 10 years for the successful completion and commissioning a De-inked pulp of capacity 100 TPD or higher.

2. The average annual turnover of the bidder during the preceding 3 financial years from consultancy work should be a minimum of Rs.10 crore.

3. The Bidder should have registered Profit Before Tax (PBT) in any of the 3 out of 5 preceding financial years.

EMD/Bid Security shall be furnished by means of a Demand Draft drawn in favour of HINDUSTAN NEWSPRINT LIMITED, payable at Ernakulam/Cochin/Mavelloor from any Indian Scheduled Commercial Bank along with the techno-commercial bid. Alternatively, the same can be furnished by means of a Bank Guarantee, as per our Proforma, valid for 180 days, from an Indian Scheduled Commercial Bank.

The bids prepared in the manner mentioned in the bid document will be received till 14.00 hrs. (IST) on 08.09.2010 along with the Bid Security specified, which will be opened on the same day at 14.30 hrs (IST) in the presence of interested Bidders.
