"INCREASING INSURGENCY IS WORRISOME": Raji Philip



The Media Conference on HPC performance for FY 2007-08 was held at Pala Banquet Hall, ITC Sonar Kolkata on April 22, 2008. A huge number of senior Media Correspondents from leading National Dailies, Financial Dailies, Vernacular Newspapers and the Electronic Media were present.

In his address to the Media, Shri Raii Philip, CMD expressed his deep appreciation for the generous support received from the Media over the years. He said "I am glad to present the highlights of our Company's performance for the 8th time in a row." Unfolding the future growth plans of

HPC, CMD highlighted that HPC is poised to become a 3,000 Crore Company by 2013 by scaling up the capacity to 8,00,000 tonnes/annum of paper and newsprint from the present level of 3,00,000 tonnes/annum.

Answering various questions from the Media, he narrated how the Assam based Mills have been affected due to raw material crisis and yet performing at its peak.

Cachar Paper Mill which was at one point of time slated to be written off by experts proved wrong. To tide over the fibre scarcity, HPC

has set up a state-of-the-art Tissue Culture Laboratory to supplement the raw material requirement. Regarding Corporate Social Responsibility he explained in brief the proactive measures taken by HPC in offering various Community Services to the Mill neighbourhood. HPC's endeavour to reduce carbon dioxide emission by way of pursuing Clean Development Mechanism (CDM) Projects was also brought forth. Touching on financials, CMD revealed that the Corporation has posted record turnover of Rs.1137 Crore in FY 2007-08 with record sales and production output. Earlier, Shri Jagdish Borah, welcomed the media personnel and all others present. Shri M V Narasimha Rao, Director (Finance) presented the operational highlights and achievements through a Power Point Presentation.

HPC SIGNS MoU WITH Gol





On March 31, 2008 Hindustan Paper Corporation Ltd concluded the Memorandum of Understanding (MoU) of the FY 2008-09 with the Govt. of India. Shri Raji Philip, Chairman-cum-Managing Director, HPC and Dr.Satyanarayana Dash, Secretary to the Govt. of India, Dept. of Heavy Industry signed the MoU at Udyog Bhavan, New Delhi.

During FY 2008-09, HPC would aim to achieve a sales turnover of Rs.1313 crore with a sales volume of 348000 tonne through enlarged market share by increasing thrust on open market sales along with bulk sales to Institutional Sectors. This apart, the Corporation would also ensure optimum utilisation of existing assets for maximizing generation of internal resources for funding modernization and expansion of installed capacity as also creation of production capacity at new locations. To be a dominant player in the writing, printing paper segment HPC would also strive for addition of value added paper and quality newsprint. HPC would implement Modernization and Technical Upgradation Plans at its Mills. HPC would also put due emphasis on following parameters to attain sustained growth.

- ♦ To attain a group sales turnover of Rs.3000 crore by 2013.
- To continually upgrade and upscale production and enhance market share.
- To explore utilization of locally available renewable raw materials eventually to reduce dependence on forest based resources.
- To spearhead applied research for adoption of state-of-the-art technological breakthroughs in operational efficiency.
- To preserve ecological balance in the vicinity of the Mills as a responsible and responsive Corporate Citizen.

TARGET FOR 2008-09

CPM DIVAS


