This has reference to the subject cited above and the letter under reference.

It is observed from the said order passed by the Hon'ble High Court to disburse the PF amount to the workmen @20.58% on pro-rata basis against amount received by EPFO as past accumulation as on date for immediate monetary succor on the basis of the audited statement prepared by M/s Manish Barelia & Co., the Chartered Accountants. It has also been directed to release the payment within one week from the date of receipt of the Court's order dated 24.04.2020 received by this office on 27.04.2020.

In this connection, it is inform that this office has not received any claims from the member as on date. In order to comply the Court's order, it is requested to submit the claims through online in EPFO portal or offline immediately.

It is also stated that PF claim in Form-19 in respect of the employees of HPCL, i.e. M/s Jagiroad Paper Mill will be settled by this office. The claims in respect of HPCL (Corporate Office) and employees of M/s Cachar Paper Mill cannot be settled by this office as there are no relevant records available with this office.


